NEW – FIREWORKS BY-LAW

The Township of Tiny has enacted a new Fireworks by-law as follows:

1. Fireworks can only be discharged on Victoria Day, Canada Day, New Year's Eve and New Year's Day.
2. Fireworks can be discharged between dusk and 11:00 pm; with the exception of New Year's Eve (dusk to 1:00 am).
3. Fireworks cannot be displayed or sold except on Victoria Day, Canada Day, New Year's Eve and New Year's Day, or for a period of seven (7) days calendar days immediately preceding these days. For more information, go to: <https://www.tiny.ca/fireworks>

NEW – WASTE MANAGEMENT CART EXCHANGE
