Dune Stewardship

Our beachfront is not just an isolated piece of geography; it is part of an ecosystem that includes the sand we sit on, the sandy lakebed, the sand bars and the sand dunes. They all operate together. If we mess with one part, we mess with them all.

Georgian Bay's sandy beaches and dunes are considered to be "relic" sand - deposits formed by geologic processes millennia ago. This makes it a finite resource and places a greater sense of urgency and need for good beach stewardship. Sand dunes are simply an extension of the beach: a reservoir of sand that the lake 'borrows' from time to time during storms when the waves erode the dune and carry the sand into the lake to form protective sand bars.

The sand bar acts as a temporary protective berm, absorbing wave energy that would otherwise reach the shore potentially causing erosion to the beach and dune. Once a storm subsides, gentle waves gradually return sand back to the shore. Wind blows sand from the beach back into the dunes. If this cycle is disrupted, our beautiful sandy beaches will erode away. The dunes are our insurance policy for the next high water period. They store sand for when it is needed to feed storm waves that would otherwise start eroding or damaging the beachfront.

Draft Bylaw Revision

At the 2016 Deanlea **Beach Association Annual** General Meeting. members requested the Board of Directors undertake a review of the Association Bylaws. The Executive has done so and is sharing a draft of the revised Bylaws for review and discussion at the 2017 Annual General Meeting. The request to review the Bylaws was suggested to ensure that processes for succession planning, management of Association matters and

responsibilities are clear, transparent, actionable and undertaken in a modern way. The review of the Bylaws was timely given a review had not been conducted for many years. The Bylaws are built on common and emerging practice in nonprofit governance and follow suggested practice built on the 2010 Not-for-**Profit Corporations Act** (not yet in force). The template, while reflective of Ontario's jurisdiction, is used in similar form and

focus Canada-wide and internationally for not-forprofit and charities. The review of the Bylaws included engagement and input fromDBA members outside of the sitting Executive. We look forward to the discussion on the Bylaws and the opportunity to clarify the role and responsibilities of the Executive to force a productive relationship with the Members of the DBA on our mutual and common interests.

FoTTSA Representative Needed

The DBA requests that a community member volunteer to serve on the Board of FoTTSA (Federation of Tiny Township Shoreline Associations). This advocacy group has shaped activities within Tiny and our participation would be valuable (especially since we pay a \$500 membership fee).

Board duties vary but all Board members commit to some aspect of board activities, e.g. Tiny Cottager production requires writers, editors, delivery people, etc.; other activities include monitoring Council, water testing program, official plan monitoring, environmental issues, communication.

The Board meets about 6 times each year, in Tiny during the summer, and by conference call offseason. FoTTSA would be delighted if someone from Deanlea is interested in serving on the Board -with the understanding new board members must be selected and approved by the current Board.

If interested, you can get further information on the FoTTSA website (tinycottager.org) or by discussing Board experience with Mary Jane Price who was a highly involved and effective Board member from Deanlea for years. Let a member of the DBA Board know you're interested.

Water Testing

FoTTSA conducts a water testing program every two years to record the quality of Tiny Township shoreline and selected stream waters in summer months. In July and August 2016, Deanlea Beach was one of 58 separate shoreline locations for which water testing was performed. The 2016 results are summarized in the table below. If the E. coli count exceeds a threshold of 100 per 100 mL, beach posting is recommended. Deanlea has had consistently low E. coli bacteria levels for years, due to our favourable location. High E. coli levels have been observed in days following rain storms. For further info on water quality, see the Tiny Cottager website: http://tinycottager.org. A big thanks goes to Carolotta Lee, who has taken weekly samples at three locations on the day following each weekend for many years. (Thanks also to Christine Gaiotto, who filled in for Carolotta, when needed.) Please read the draft revised bylaw.. We welcome your input at the AGM. Ultimately we hope to vote on a final version at the 2018 AGM.

Property Development

Property development at Deanlea Beach can have an impact on our common property. We would like to remind residents to consider the potential impact of construction projects on the following areas: 1) Roads - please ensure that contractors restore road surfaces that may be affected by heavy equipment; 2) Trees - please do not cut down any trees that are not on your property; 3) Footpaths - please do not encroach on DBA footpath borders. Thank you for continuing to respect our common property.

DBA Membership Fees

The annual dues are now \$60 and if you pay on or before the AGM on Saturday June 24 you can take advantage of the early payment discount and pay \$50 (\$51.50 via PayPal). Those who pay later will have to pay the full \$60 (\$61.50 via PayPal).

4. PayPal – click on the PayPal icon at www.deanleabeach.ca – this allows for secure payment by credit card: please pay \$51.50 (\$61.50 after the AGM) as DBA has to pay a processing fee.
