#### ANNUAL GENERAL MEETING

#### TREASURER'S REPORT - PRELIMINARY 2017 FINANCIAL INFORMATION

The most recent review of DBA finances shows that we will be in a net loss position for the first time in several years. Revenues are forecast to be down due to a lower number of paid members and lower raffle ticket sales during Fun Day. Expenses increased in 2017 due largely

to increased road maintenance activities.

A full discussion of DBA financial position will be held at the Annual General Meeting in June 2018.

#### FIRE ACCESS ISSUE

Last year, the Township Fire Chief identified Deanlea Beach as one of the most complex unassumed road networks in Tiny and expressed a concern to the DBA about the difficulty in gaining quick fire truck access to some of our road locations. In follow-up meetings with the DBA, the Fire Chief communicated the

complex, multiple-truck logistics that the Fire Dept. must use to supply water to a potential fire site. He also stressed the importance of ensuring that all gravel roads were always clear from obstructions and able to accommodate wide pumper trucks. Discussions with the Fire Dept. will continue and community

outreach on several issues is an important priority. As a community, our responsibility is to ensure that all gravel roads are accessible and part of this means that we must be vigilant on our No Parking on Gravel Roads rules. We will likely start to have broader discussions about snow clearing in winter months.

#### FIRE HYDRANT REQUEST

In discussions with the Tiny Township Fire Chief in the Fall of 2017, the DBA asked about access to fire hydrants. Deanlea Beach has only two fire hydrants, which are located at: 1) 2 Pineshore Cres. (north end); and 2) 1420 Tiny Beaches Rd. S. (north of Deanlea Blvd. entrance). After making inquiries, the Fire Chief confirmed that the water mains on the Deanlea paved roads are 6" diameter

pipes, which is considered the minimum size to supply a sufficient flow to hydrants. The Fire Chief supports the idea of installing one or more fire hydrants at locations closer to the gravel roads, since this would reduce the complexity of the fire truck logistics. However, the Fire Dept. cannot request this directly from Tiny Council for Deanlea Beach. He advised that the DBA must prepare a

formal request to Tiny Council to consider the installation of one or more fire hydrants at strategic locations to broaden the fire water supply and, when Council seeks technical input, the Fire Dept. will support the request. The DBA will prepare such a presentation for Tiny Council this Spring.

#### WATER TESTING

The Federation of Tiny Township
Shoreline Associations (FoTTSA) is
planning to organize the local beach
volunteer water testing program again this
year and the DBA would like to have
volunteers to help with the sampling. A
community-based water testing program
has occurred every two years for the last
decade (most recent was 2016). We
thank Carlotta Lee and her helpers for
many years of wetting their knees for our
peace of mind. The Simcoe Muskoka
District Health Unit (SMDHU) will continue

to monitor E. coli levels at the five public Tiny beaches, which includes the Bluewater Beach Park, just north of us. To refresh our understanding of the issue, our beach at Red Rock has had a remarkably clean record among all Tiny beaches over the years, with E. coli counts of 20 per 100 ml or less for the majority of the summer weeks. Readings have increased after stormy weather. Historical water testing results for Tiny are available from FoTTSA. Health Canada and the SMDHU sets the following

contamination limits for primary contact activities (swimming) in fresh water:

- a geometric mean concentration (minimum of five samples) ≤ 200
   E. coli/100 ml; and
- a single-sample maximum concentration ≤ 400 E. coli/100 ml.

It is comforting to know that we are well below these limits but we must continue to observe good septic tank management and hygiene practices in our shared water resource.

#### WATERCRAFT OPERATION

Every year, several members have had concerns regarding the operation of water craft near the Deanlea Beach shore. It may be useful for all to be aware that Transport Canada sets rules for power-driven watercraft operation in

recreational waters and that there is a maximum speed limit of 10 km/h set for a zone extending out to 300 metres from the western shore of Tiny. Transport Canada created this wider zone to respect the fact that our waters are quite

shallow and that there is widespread personal use of these waters in summer months. Please continue to respect the shared use of our beach waters with controlled piloting of watercraft.

#### DBA LAWYER RETIRED - NEW LAWYER SEARCH BEGINS

Gary French, Barrister and Solicitor, of Elmvale has acted as corporate lawyer and provided a head office address for the Deanlea Beach Association since the 1980s. While the DBA has not required his services since the late 1990s, he provided support to the DBA in our early years for various legal and organizational initiatives, including deed transfer, By-law

revision, the strategy against proposed landfill development, and beach ownership inquiries. He informed the DBA that he was retiring and closed his office in Elmvale in October 2017. On behalf of DBA members, the board would like to thank Gary French for all his help during our formative years.

We would like to begin the process to identify and select a new corporate lawyer who could be our primary contact for legal and governance inquiries, if deemed necessary. We want to notify DBA members that we are starting this process and welcome any input from members who have expertise or who could provide professional advice.
